## **Scope and Content Note**

The papers of Leonard James Dow (1902-1967) span the years 1945-1967, with the bulk of the material from 1956 to 1963. The collection consists of correspondence, subject files, speeches and articles, and miscellaneous material.

Much of the material concerns Dow's career after his retirement in 1956 from the United States Navy. Subject files treat his association with business firms and his position as consultant for civil defense, antisubmarine warfare, and communications. There are also papers concerning Dow's duty in the South Pacific and his membership in an advanced study group at the United States Naval War College.

Prominent correspondents include Robert Bostwick Carney, William Frederick Halsey, John Tucker Hayward, Noel B. McLean, William K. Mendenhall Jr., Gilven M. Slonim, Lloyd Preston Smith, Harold Edward Stassen, and Ronald A. Veeder.
