**Summary:** United States senator and representative from Virginia and Confederate diplomatic agent in Great Britain. Chiefly diplomatic communications sent while Mason was a Confederate commissioner. Includes correspondence; dispatches; lists of supplies for the Confederate States from London; statements and depositions regarding piracy, claims, the blockade, and other naval and marine matters; cotton bonds and warrants; circulars; and printed matter.

## **Scope and Content Note**

The papers of James Murray Mason (1798-1871) span the period 1838-1870, with the bulk of the material dating from 1862 to 1865. The collection consists chiefly of Mason's diplomatic communications as Confederate commissioner to Great Britain and includes correspondence, dispatches, lists, statements and depositions, cotton bonds and warrants, circulars, and printed matter.

The papers include instructions to Mason from Confederate officials R. M. T. Hunter, J. P. Benjamin, and William M. Browne as well as letters from the British Foreign Office. Also included is correspondence regarding the *Trent* Affair; the log of the HMS *Rinaldo*, 1862; letters and other papers regarding British merchant vessels; a report on the attack of the CSS *Virginia* (Ironclad) on Federal ships in Hampton Roads, Virginia; and letters concerning fuel to Mason from officers commanding Confederate ships in European waters.
