Scope and Content Note

The papers of David Foote Sellers (1874-1979) span the years 1860-1949, with the bulk of the material concentrated in the period 1927-1938. The collection consists of journals, correspondence, photographs, scrapbooks, and newspaper clippings. It reflects all aspects of Sellers's service from his duty as cadet midshipman in 1890 to his last active duty as superintendent of the United States Naval Academy. The collection is organized into six series: [Journal, Personal Logs, and Fitness Reports](#); [Correspondence](#); [Special Service Squadron File](#); [Miscellany](#); [Photograph Album](#); and [Scrapbooks](#).

Sellers served in the Spanish-American War, the Samoan campaign, and during the Philippine American War. He also had duty as a naval aide to the White House in 1903-1904, temporary duty as aide to the commander of the division of German ships visiting the United States in 1912, and service in connection with the Panama-Pacific International Exposition in 1915.

Sellers kept a file of his fitness reports that is complete from his days as a junior officer through his duty as superintendent of the naval academy. In addition to his cadet journal, he kept one while on board USS *Birmingham* and another while on board USS *Agamemnon*.

Much of the correspondence in the collection relates to the problems Sellers faced when he was on two years' duty as commander, Special Service Squadron, in Nicaragua from 1927 to 1929. Other correspondence relates to his duty as commander of the Naval Training Station at San Diego, as commander in chief of the United States Fleet, and as superintendent at the naval academy. Correspondents include Charles Francis Adams, Harry Alexander Baldrige, Hanson Weightman Baldwin, Richard Evelyn Byrd, Harold W. Dodds, Helen Keller, and Dudley Wright Knox. Of interest is the exchange of letters between Sellers and Adolphus Andrews, over the latter's description in a college thesis of the passage of the fleet through the Panama Canal in 1934 under the command of Sellers.

Sellers's naval career is also documented by snapshots and professional photographs and by scrapbooks of newspaper clippings and memorabilia. There are two large albums containing material on the first naval overseas flight of six seaplanes from San Francisco to Honolulu in 1935.
