The records of the New York Society for the Suppression of Vice were arranged and described in processed and prepared for microfilming in 1986. The finding aid was revised in 2012.

## **Organizational History**

The New York Society for the Suppression of Vice was founded in 1873 by Anthony Comstock and his supporters as a committee within the Young Men's Christian Association of the City of New York to supervise public morality in the state, bring offenders to justice, and advocate for stricter legislation against immoral conduct. Chartered by the state legislature, it became prominent as a monitor and censor of literary works and popular literature. Comstock, who became its secretary, was succeeded after his death in 1915 by John S. Summer. The society was dissolved after Summer's death in 1950.

## **Scope and Content Note**

The records of the New York Society for the Suppression of Vice span the years 1871-1953. The collection consists chiefly of reports relating to persons arrested as a result of the society's actions, including data on the offender's age, nationality, religion, education, offense, evidence seized, and legal action taken. Included are notations by Anthony Comstock, secretary of the society (1873-1915), and records relating to the society's predecessor, the Young Men's Christian Association of the City of New York Committee for the Suppression of Vice. Also in the collection are miscellaneous correspondence, photographs and other papers.

## **Arrangement of the Papers**

This collection is arranged largely as received, mostly in bound volumes, and in the order it was filmed.
