Scope and Content Note

The papers of Frederick Haynes Newell (1862-1932) span the years 1885-1931. The collection consists of correspondence, diaries, articles, subject files, and clippings relating primarily to Newell's service in the United States Reclamation Service and on the United States Public Lands Commission and the National Advisory Board for Fuels and Structural Materials. Included are personal and family materials and notes of his son, Roger S. Newell. The collection is organized into four series: [Diaries](#), [Letters Sent and Received](#), [Newspaper Clippings](#), and [Publications and Miscellany](#).
