**Summary:** Foreign service officer and his wife. Correspondence, films in digital format, photographs, memoranda from Tokyo Embassy prior to bombing of Pearl Harbor as well as a diary kept after the bombing recording daily activities while detained by Japan inside the embassy, and other papers related to postings, 1924-1941, in El Salvador, Hungary, Italy, Japan, Poland, and Sweden, and family matters in New England and New York.

## Acquisition Information

The papers of Edward S. Crocker II and Lispenard Seabury Crocker, foreign service officer and his wife, were given to the Library of Congress by Edward C. Green in 2018, 2019, and 2021.

## Processing History

The papers of Edward S. Crocker II and Lispenard Seabury Crocker were arranged and described by Karen Linn Femia in 2019. The addition was processed and the finding aid revised by Karen Linn Femia in 2022. Digital files were processed by Kathleen O'Neill.

Digital files were received as part of the Edward S. Crocker II and Lispenard Seabury Crocker Papers on a single piece of storage media and assigned a unique digital ID number. Use the digital ID number to request access copies of the files associated with each media. A description of the standard processes taken on all born digital records can be found in the Processing History Note: Born Digital Collection Material at <https://hdl.loc.gov/loc.mss/eadmss.digital>.

A single DVD-R (digital ID mss86263\_171\_001) was processed in 2018 and compared to a single DVD-R received in 2021. Analysis confirmed the 2021 DVD-R contained identical content of higher quality. A reference copy of that DVD-R was made and assigned digital ID mss86263\_248\_001, which replaced the 2018 file, digital ID mss86263\_171\_001.

## Transfers

Five film canisters and seven VHS videocassettes have been transferred to the Motion Picture, Broadcasting, and Recorded Sound Division where they are identified as part of the Edward S. Crocker II and Lispenard Seabury Crocker Papers. Patrons are encouraged to contact the Motion Picture, Broadcasting, and Recorded Sound Division in advance of a research visit.

## Copyright Status

Copyright in the unpublished writings of Edward S. Crocker II and Lispenard Seabury Crocker in these papers and in other collections of papers in the custody of the Library of Congress has been dedicated to the public.

## Access and Restrictions

The papers of Edward S. Crocker II and Lispenard Seabury Crocker are open to research. Many collections are stored off-site and advance notice is needed to retrieve these items for research use. Access to digital content is available onsite only in the Manuscript Reading Room and requires advanced notice. Researchers are advised to contact the Manuscript Reading Room prior to visiting.

## Digitized Content

The 16mm home movies in the collection, titled "Crocker Family Archives," were digitized by the donor in 2008 and can be requested using the digital ID mss86263\_248\_001. The original films and a set of VHS copies of the films were transferred to the Motion Picture, Broadcasting, and Recorded Sound Division.

## Scope and Content Note

The papers of Edward S. Crocker II (1895-1968) and Lispenard Seabury Crocker (1902-1984) span the years 1892-2003, with the bulk of the material dating from 1923 to 1941. The collection documents the career and family life of a United States foreign service officer and his wife at multiple postings in Europe and Latin America, culminating with his work at the embassy in Tokyo 1934-1941. The papers are arranged into the following series: [Digital Files](#), [Family Correspondence](#), [General Correspondence](#), [Miscellany](#), [Photographs](#), [United States Embassy, Tokyo, Japan, 2022 Addition](#), and [Oversize](#).

Two decades of family letters, home films, and photographs capture the private life of the Crockers while serving at postings in San Salvador, Warsaw, Rome, Budapest, Stockholm, and Tokyo. The papers document their marriage, the birth of two children while abroad and the death of one, the social life of the diplomatic corps, and the financial contributions of family to support the diplomatic life of the Crockers. After leaving Tokyo in 1942, Crocker had further postings in Lisbon, Warsaw, and served as ambassador to Iraq (1948-1952), but there is very little material in the collection dating after 1941. The papers focus on Edward and Lispenard, but other prominent family members include her parents, Katharine Emerson Hovey Seabury and William Marston Seabury, his mother, Marion Crocker, and their daughter, Lispenard ("Lisa") Crocker, who married the future ambassador and assistant secretary of state, Marshall Green, in 1942. The papers include a folder of correspondence, some photographs, and film footage of Marshall Green.

The Crockers were in Japan from 1934-1941/1942 where Edward served as first secretary at the American embassy. The papers include two volumes of 1941 memoranda of conversations of embassy officials and the ambassador with Japanese officials. Their time in Japan is documented throughout the papers and include letters with firsthand accounts of events during the attempted coup of February 1936, letters home discussing the invasion of China, photographs, and letters and clippings documenting social events within the diplomatic corps and at the Imperial Palace. Edward Crocker was the American official who accepted the declaration of war from the government of Japan on December 8, 1941. He, along with

the other embassy staff, were then held captive inside the embassy compound for six months, an experience documented by Crocker in his 112-page diary. Edward Crocker's descriptions of these events along with the memoranda are in the United States Embassy, Tokyo, Japan series and the 2022 Addition, which includes his complete diary.

BOX 1

#### Digital Files, 1928-1960

The Digital Files consist of motion pictures, primarily ones made by the Crockers with a home camera, but also include several newsreels. The original films were digitized on September 22, 2008, by the donor, stored on a DVD-R, and organized into seven video chapters. Each chapter runs about an hour in length, except the last, which is thirty-three minutes long.

Each chapter includes multiple individual films. The chapter descriptions have estimated dates for the original films and a skeletal contents description. A partial listing of contents was provided by the donor and is filed in box 1 of the collection.

Material types include digital files created by the donor from home movies and newsreels and a contents list.

#### Family Correspondence, 1900-1967

Family Correspondence is the largest series and is primarily composed of letters written by Edward and Lispenard to their parents and to each other while serving abroad at various embassies and legations. The correspondence is organized by the name of the family member who wrote the letter. Edward's correspondence begins with letters from his college days at Princeton and during his service in U.S. Navy in Europe during World War I.

In addition to letters about his various foreign service posts, he also writes frequently about family vacations in rural Maine. Lispenard's letters begin with her youthful European travels followed by her courtship and marriage to Edward Crocker.

Material types include correspondence with some photographs as attachments.

#### General Correspondence, 1923-2003

General Correspondence contains both professional and non-family personal correspondence.

The United States Embassy, Tokyo, Japan series holds documents relating to embassy events in the lead up to and directly following the bombing of Pearl Harbor in 1941. In addition to the two volumes of 1941 embassy memoranda concerning conversations with Japanese officials, the series includes a copy of an eight-page "diary" by Edward Crocker for December 8, 1941, and a description of living conditions during his incarceration.

**2022 Addition, 1930-1942**

The 2022 Addition contains the original carbon copy of the 1941-1942 Tokyo embassy diary of Edward S. Crocker covering the beginning of the detention of embassy personnel after the bombing of Pearl Harbor on December 8, 1941, and stopping on February 19, 1942. The diary provides a daily recounting of activities in the American embassy and whatever news and information Crocker was able to gather from outside the embassy. Also in the addition is a file of personal letters from Sinclair Lewis and several photographs of the writer, as well as two letters by Edward Crocker to family in the United States describing a 1935 trip to China while stationed in Japan.
